Public Utilities Director Josh Nelson provided a staff report explaining the revisions to the amended and restated agreement with La Puente Valley County Water District. The term of this agreement will, if approved, expire March 31, 2039, and increase by three percent (3%) of the amount of the prior years' management fee. Commissioner Ruggles asked if it was determined that the agreement was not workable, would they be able to terminate the agreement? Assistant General Counsel, Bianca Sparks responded for the record that essentially a 120-day termination notice is required. We must give a 30-day notice to try to work through whatever the issue is. If we cannot work through the issue, then a 90-day termination notice is done.

Mike Greenspan and Armando Herman each spoke for one minute in opposition to the Consent Calendar.
