Mid-Year 2015-2016 Budget Update

This Mid-Year budget update is to update the Public Facilities Authority's budget to reflect the issuance of the Authority's \$574,905,000 Tax Allocation Revenue Refunding Bonds, Series A & B in order to acquire the Local Obligations issued by the Successor Agency to the IUDA to provide proceeds to the Successor Agency to refund and defease its bonds.

# Summary

Budgeted revenues have been increased by \$466,015,854 which represents the net proceeds recorded to the income statement in the sale of the Authority's 2015 bonds.

Expenditures have decreased by \$16,028,480 which represent the principal and interest payments on the Authority's 2007 Tax Allocation Bonds which were refunded as part of the 2015 bond issuance.

The first principal and interest payments due on the Authority's 2015 Tax Allocation Revenue Refunding Bonds, Series A & B bonds will be due in the next fiscal year of 2016-2017.

In addition the transfers-in from the City's Tax Override fund have been increased by \$74,086,677 which is also part of the bond issuance transaction.

### **Fiscal Impact**

The net effect of this amendment will increase the Authority's debt service fund balance from June 30, 2015 by \$539,984,641 to \$626,783,937 at June 30, 2016 which the fund balance is 100% reserved for debt service on the Authority's bonds.
