On April 12, 2017 the City of Industry's ethics monitor submitted a report to the City Council. Some of his recommendations related to the work of the COI's Housing Commission. Specifically, Mr. Lockyer suggested: cost controls on city housing expenditures, a formal application procedure, a continuing effort to shift housing stock to city ownership, and a policy making that assessing compatibility of housing expansion that balances environmental and legal exposure in an industrial city.

We would like to be responsive to Mr. Lockyer's suggestions and would like to work with him on drafting policy changes that accomplish our mutual goals.

We are asking for a dedicated staff resource and a dedicated legal resource to help us draft a response and recommended policy changes for ultimate consideration by the City of Industry City Council.


Dear Mr. Philips,
