Please find the attached March 21, 2016 correspondence outlining a request for housing assistance. IT IS RECOMMENDED that the Property and Housing Management Board direct staff accordingly.

To The City of Industry Housing Authority,

I would respectfully like to ask for immediate assistance in obtaining a home in the city for myself and my family due to some traumatic events that have happened in our lives. Currently, I am the sole provider for my family as my husband lost his job. Having to pay less for rent would help in making our lives more manageable. Financial analysts estimate that 1/3 of your income should go towards housing and I can assure you I am putting much more than that towards our housing. We have 2 girls, one is 13 and starting high school next year and one is 18 and in college. As I am sure you are aware, it takes two incomes now a days to make ends meet. Things have been tough trying to make it on one income.

Another benefit to living in the COI is I would be closer to my job in Santa Fe Springs. It would cut my commute in half. It is also closer for my daughter who goes to Mt Sac. Both my parents are older and have health issues. My dad turns 80 in April and my mom is 75. They need me to assist them after work and on the weekends and cutting down on my commute helps tremendously. I also have a brother with a mental illness (schizophrenia) that needs assistance from me as well. We understand there are industrial impacts that we will deal with while living in the COI and I can assure you my family is willing to deal with them.

Thank you for your consideration of our request for a house. Anything you can do would be a tremendous help to me and my family.
