Background:

On January 25, 2018, the Successor Agency to the Industry Urban-Development Agency ("Agency") awarded Contract No. IBC-0386, West Side Roadways, Sewers, Dry Utilities and Slope Landscaping, to Sialic Contractors Corporation dba Shawnan, in the amount of \$24,969,171.10, which includes a contingency amount of \$1,000,000.00.

This project is the last major phase of work associated with the Industry Business Center and it includes the west side roadways, sewers, dry utilities and slope landscaping.

Discussion:

After the contract was awarded sewer plan revisions were issued to the contractor which were not part of the original contract, but were requested by the Los Angeles County Public Works Department as part of their final plan check comments.

As of September 10, 2018 the Agency Engineer has reviewed the following change order for completeness and accuracy as to the materials and labor included:

Change Order No. 1: The Contractor was issued sewer plan revisions which were requested by the Los Angeles County Public Works Department as part of their final plan check comments. The revisions include replacing the 10-inch vitrified clay pipe (VCP) with a 12-inch VCP, replacing the 8-inch VCP with ductile iron pipe (DIP) with restrained joints, installing approximately 1,567 lineal feet of a concrete cradle (see Standard Plan) and approximately 14 lineal feet of concrete encasement (see Standard Plan). The Contractor submitted a total cost in the amount of \$158,139.22.

Fiscal Impact:

The current revised contract amount, excluding contingency is \$24,127,310.32. The total change order amount is \$158,139.22 which is 0.66% of the original contract amount. Total approved budget is \$24,969,171.10. No additional appropriations are necessary at this time.

Recommendations:

- 1.) Approve Change Order No. 1 in the amount of \$158,139.22 and;
- 2.) Authorize the Acting Executive Director or his designee to execute the approved change order.


