**RESOLUTION NO. CC 2019-11**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF INDUSTRY,  
CALIFORNIA, CANCELLING THE JUNE 4, 2019, GENERAL MUNICIPAL  
ELECTION AND PROVIDING FOR THE APPOINTMENT  
TO THE OFFICE OF COUNCIL MEMBER**

**WHEREAS**, pursuant to Section 10229 of the Elections Code of the State of California, as of the close of the Nomination Period on March 8, 2019, there are not more candidates than offices to be elected, and that Section 10229 of the Elections Code allows one of the following courses of action to be taken by the City Council:

1. Appoint to the office the person who has been nominated;
2. Appoint to the office any eligible elector if no one has been nominated;
3. Hold the election, if either no one or only one person has been nominated; and

**WHEREAS**, only three candidates were nominated for the three City Council seats to be filled at the June 4, 2019, general municipal election; and

**WHEREAS**, there are no other city offices to be filled at the June 4, 2019, general municipal election; and

**WHEREAS**, on March 13, 2019, the City Clerk delivered to the City Council the certificate required by Section 10229 of the Elections Code, which is attached hereto as Exhibit "A" and incorporated herein by reference; and

**WHEREAS**, on March 15, 2019, the City Clerk posted and published the notice required by Section 10229 of the Elections Code; and

**WHEREAS**, pursuant to Section 10229 of the Elections Code, the City Council desires to appoint the three persons nominated for office of Council member: Cory Moss, Newell Ruggles and Mark Radecki to four year terms, as if they were elected at the June 4, 2019 general municipal election.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF INDUSTRY,  
DOES HEREBY FIND, DETERMINE AND RESOLVE, AS FOLLOWS:**

**SECTION 1.** The election scheduled to be held on Tuesday, June 4, 2019, is now canceled.

**SECTION 2.** That pursuant to Section 10229 of the Elections Code, the following persons are being appointed to the offices to which they were nominated, and are considered to be the same as being elected:

Newell Ruggles	Member of the City Council	Full Term of Four (4) Years

**SECTION 3.** The person(s) appointed, if any, shall qualify and take office and serve exactly as if elected at a municipal election for the office.

**SECTION 4.** That the City Clerk is directed to transmit a certified copy of this Resolution and all necessary documents to the Los Angeles County Registrar of Voters and Board of Supervisors.

**SECTION 5.** The City Clerk is hereby directed not to accept for filing any statement for a write-in candidacy after the appointments are made.

**SECTION 6.** The provisions of this Resolution are severable and if any provision, clause, sentence, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstances, such illegality, invalidity, unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, sections, words or parts thereof of the Resolution or their applicability to other persons or circumstances.

**SECTION 7.** That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.

**SECTION 8.** This Resolution shall take effect immediately upon adoption.
