#### **PUBLIC COMMENTS**

Executive Director of the Industry Business Council, Joanne McClaskey asked to speak to the Council regarding the South Coast Air Quality Management District (SCAQMD) Indirect Source Rule (ISR2305) which will be voted on May 7<sup>th</sup>. She provided a presentation and explained the Rule to the Council.

This proposed air quality rule is designed to hold warehouses accountable for the emissions from truck trips/deliveries to/from their location. Most warehouse operators do not own/operate the trucks delivering to their warehouse.

The new rule requires warehouse operators to either reduce truck emissions (by using electric trucks) and/or pay fees to SCAQMD. This imposes costs on the warehouses, there are reporting requirements and it will be the responsibility of the facility owner to report to the AQMD the tenants in the targeted buildings. There are approximately 500 pages of documentation regarding this proposed Rule.

There are currently a lot more questions than answers regarding most aspects of the Rule: poor communication regarding requirements, lack of notice/direction for targeted operators, website resources are difficult to navigate, multiple companies operating within a targeted warehouse, compliance enforcement, reports not filed, fees not paid, etc.

Business organizations and industrial property owners have been critical of the proposed Rule stating that the Rule is not ready for Roll-Out and is still very convoluted.

Mayor Moss said that this is very troubling and said we surely will be hearing more about this in the near future and thanked Joanne McClaskey for her reporting.
