## Background:

At the June 7, 2022 Civic Center Design & Development Advisory Committee ("CCDDAC") meeting, the Committee directed staff to draft a scope of work for architectural style and urban design of the Civic Center and related services.

## Discussion:

Staff drafted a scope of work that can be incorporated into the City's standard Request for Proposal ("RFP"). The scope of work is as follows:

- 1. Assist with creating a mission statement for the City of Industry Civic Center.
- 2. Assist the City with the selection of an architectural style and development of urban The proposer must demonstrate knowledge of both design guidelines. architecture and construction costs, and experience in preparing guidelines.
- 3. With the assistance of the City, preparation of a land use plan, with use categories. The proposer must have experience in similar setting.
- 4. With the assistance of the City, preparation of a public improvement plan. The proposer must have experience with streets, landscaping/medians, light standards, bus benches, trash cans, street treatment, public art/statues/signs, or similar public improvements.

If the scope is approved by CCDDAC, Staff will present the scope to the City Council and request authorization to issue a RFP to procure said services. CCDDAC will be an integral part of the procurement process, but the City Council has the sole authority to award the proposed contract, and may also amend the scope of services.

## **Fiscal Impact:**

Approval of the proposed scope of work and issuance of a RFP poses no fiscal impact. However, if a contract is awarded, the contract's not-to-exceed amount may need to be appropriated from the City's General Fund into the appropriate expense account code. Additionally, future costs should be anticipated and will fiscally impact the City's General Fund as the development of the Civic Center is explored.

## **Recommendation:**

1.) Staff recommends that the CCDDAC approve the scope of work for architectural style and urban design of the Civic Center.
