Recommendation:

Adopt Resolution No. THCA 2022-18 entitled: A RESOLUTION OF THE BOARD OF DIRECTORS OF THE TRES HERMANOS CONSERVATION AUTHORITY MAKING SPECIFIED FINDINGS RELATING TO THE USE OF TELECONFERENCING IN ACCORDANCE WITH ASSEMBLY BILL 361 FOR MEETINGS OF THE AUTHORITY SUBJECT TO STATE OPEN MEETING LAWS.

Background/Discussion:

Due to the continued impact of the COVID-19 pandemic, the California Legislature passed AB 361 (effective October 1, 2021), which authorizes a local agency to use teleconferencing without complying with certain teleconferencing requirements imposed by the Brown Act when: (1) the legislative body of a local agency holds a meeting during a declared state of emergency; (2) when state or local health officials have imposed or recommended measures to promote social distancing; and/or (3) when a local agency has determined that meeting in person would present imminent risks to the health or safety of attendees.

The Authority first utilized the provisions of AB 361 at its Special meeting on October 25, 2021. In order to continue to have the ability to use the modified teleconferencing options, AB 361 requires that the Authority re-affirm its findings every 30 days thereafter. Conditions under which AB 361 may be utilized continue to exist as described in the attached Resolution (Attachment 1).

The Authority is currently going beyond what the Brown Act requires by holding meetings in person and by way of teleconference and allowing the public to participate in both forums. The provisions of AB 361 allowing the modified teleconferencing will

expire January 1, 2024.

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE TRES HERMANOS CONSERVATION AUTHORITY MAKING SPECIFIED FINDINGS RELATING TO THE USE OF TELECONFERENCING IN ACCORDANCE WITH ASSEMBLY BILL 361 FOR MEETINGS OF THE AUTHORITY SUBJECT TO STATE OPEN MEETING LAWS.

WHEREAS, on March 4, 2020, California Governor Newsom declared a State of Emergency in response to the COVID-19 pandemic; and

WHEREAS, on March 12, 2020, to address the impacts of COVID-19, Governor Newsom issued Executive Orders that required, among other things, residents of California to follow orders and guidance of local public health officials, including social distancing and masking requirements; and

WHEREAS, existing California law, the Ralph M. Brown Act ("Brown Act") requires, with specified exceptions, that all meetings of a legislative body of a local agency, as those terms are defined, be open and public, that a physical location for such meetings be provided, and that the public be permitted to provide public comment during the meetings; and

WHEREAS, the Brown Act permits members of legislative bodies to teleconference into public meetings subject to certain conditions, including that the place from which the member teleconferences be open to the public, that an agenda be posted on the site, and that the teleconference location be noticed in the agenda; and

WHEREAS, in recognition that such public gatherings at such meetings could accelerate the spread of COVID-19, Governor Newsom's Executive Orders suspended, among others, these Brown Act teleconferencing requirements to provide local agencies with greater flexibility to hold meetings via teleconferencing safely; and

WHEREAS, as of September 30, 2021, the Governor's Executive Order suspending the Brown Act's teleconferencing requirements expired; and

WHEREAS, on September 16, 2021, Governor Newsom signed Assembly Bill 361, which authorizes a local agency to continue to use teleconferencing without complying with certain teleconferencing requirements imposed by the Brown Act when: (1) the legislative body of a local agency holds a meeting during a declared state of emergency; (2) when state or local health officials have imposed or recommended measures to promote social distancing; and/or (3) when a local agency has determined that meeting in person would present imminent risks to the health or safety of attendees; and

- WHEREAS, both Los Angeles County and state health officials continue to recommend social distancing due to continued community spread of COVID-19 cases; and
- **WHEREAS**, the Authority first utilized the provisions authorized by AB 361 at a Special meeting on October 25, 2021, and subsequently adopted Resolution Nos. THCA 2021-06, 2021-07, 2022-01, 2022-02, 2022-03, 2022-04, 2022-07, 2022-09, 2022-10, 2022-11, 2022-12, 2022-13, 2022-14, 2022-15 and 2022-16 re-affirming its continued use.
- **WHEREAS**, the Authority must approve a Resolution reaffirming that the requirements set forth in Assembly Bill 361 exist every 30 days in order to allow members of its legislative bodies to utilize the provisions of Assembly Bill 361 when attending public meetings via teleconferencing; and
- WHEREAS, notwithstanding that the Authority, as defined by the Brown Act, are now holding modified public meetings in person, there may be situations in which a Board of Director(s) decides not to attend in person due to a particular health or safety risk posed by such attendance and as such, it is the desire of the Authority to permit its Board of Directors to attend by way of teleconference pursuant to Assembly Bill 361.
- NOW, THEREFORE, THE BOARD OF THE TRES HERMANOS CONSERVATION AUTHORITY DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:
- <u>Section 1.</u> That the above recitals are true and correct. and based thereon, that the spread and potential further spread of COVID-19 poses an imminent risk to the public health and safety.
- <u>Section 2.</u> That meetings of the Tres Hermanos Conservation Authority are held in the City of Diamond Bar, in the County of Los Angeles, in the State of California.
- Section 3. That a state of emergency due to the COVID-19 pandemic continues to exist and at the time that this Resolution was adopted both Los Angeles County and State health officials are recommending social distancing to slow the spread of COVID-19.
- <u>Section 4.</u> That meeting in person may pose an imminent risk to the health and safety of some attendees, including members of the Authority Board of Directors, who due to age, health conditions, or vaccination status, have a higher risk of contracting COVID-19 and are more likely to get severely ill and in some cases, die from COVID-19.
- <u>Section 5.</u> That during the effective period of this Resolution and any reaffirmation thereof, Authority Board of Directors may participate in meetings subject to the Brown Act by way of teleconference in accordance with Assembly Bill 361.
- <u>Section 6.</u> That meetings shall be held in accordance with AB 361 by, among other things, providing notice to the public how it can access the meeting and provide

public comment, providing an opportunity for the public to attend via a call-in or an internet-based service option, conducting the meeting in a manner which protects the statutory and constitutional rights of the public, and stopping the meeting until public access is restored in the event of a service disruption.

IT IS FURTHER RESOLVED that this Resolution is effective for 30 days from its adoption date. Subsequent appearances by teleconferencing of the Board of Directors must be affirmed/acknowledged every 30 days by the Tres Hermanos Conservation Authority in order for the provisions of Assembly Bill 361 to continue to apply.

Adopt Resolution NO. THCA 2022-19 entitled: A RESOLUTION OF THE BOARD OF DIRECTORS OF THE TRES HERMANOS CONSERVATION AUTHORITY ADOPTING THE 2022 CONFLICT OF INTEREST CODE IN ACCORDANCE WITH THE POLITICAL REFORM ACT.

Background/Analysis:

Chapter 7, Article 3 of the Political Reform Act (Act) requires every agency to adopt and promulgate a Conflict of Interest Code and Section 87303 of the Act sets forth the process for approval of the Conflict of Interest Code by the Code Reviewing Body. Every agency shall amend its Conflict of Interest Code, subject to the provisions of Section 87303, when change is necessitated by changed circumstances, including the creation of new positions. The FPPC is the Code Reviewing Body for multi-county agencies.

The Code Revision packet was forwarded to the FPPC on April 8, 2021, for their initial review and was presented to the Authority on April 21, 2021, for additional review. The Public Comment Period commenced on March 22, 2022, and closed on May 5, 2022. All affected filers were notified via email and no comments were received. The FPPC made additional revisions to the Code and the revisions were reviewed and approved by the Authority on September 14, 2022. Following that meeting, the FPPC submitted the Code for final approval and notified the THCA Filing Officer of its adoption on October 12, 2022. Staff is recommending the adoption of a resolution to adopt the final THCA Conflict of Interest Code as approved by the FPPC.

RESOLUTION NO. THCA 2022-19

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE TRES HERMANOS CONSERVATION AUTHORITY ADOPTING THE 2022 CONFLICT OF INTEREST CODE IN ACCORDANCE WITH THE POLITICAL REFORM ACT.

WHEREAS, the City of Industry, City of Chino Hills, and City of Diamond Bar entered into the Amended and Restated Tres Hermanos Conservation Authority Joint Powers Agreement ("Agreement") on February 5, 2019; and

WHEREAS, Section 3.15 entitled "Political Reform Act" of the Agreement, states the Board of Directors, shall adopt a Conflict of Interest Code; and,

WHEREAS, the Board of Directors, in accordance with the Political Reform Act, shall conduct a review of the Conflict of Interest Code biennially.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE TRES HERMANOS CONSERVATION AUTHORITY DOES HEREBY FIND, RESOLVE, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The Board of Directors finds and declares as follows:

- A. The Political Reform Act ("PRA"; Gov't. Code §§ 81000, et seq.) and regulations adopted pursuant to the PRA (Fair Political Practices Commission (FPPC) Regs.; 2 Cal. Code of Regs. §§ 18700, et seq.) requires local governments to adopt conflict of interest codes.
- B. Section 18730 of the FPPC Regs. sets forth a standard conflict of interest code that may be adopted by local agencies.
- C. To fulfill its obligations under the PRA and FPPC Regs., the Board of Directors will adopt a new Conflict of Interest Code as set forth below.

<u>Section 2.</u> Pursuant to FPPC Regs. § 18730, the Board of Directors of the Tres Hermanos Conservation Authority adopts a Conflict of Interest Code to read as follows:

CONFLICT OF INTEREST CODE FOR THE TRES HERMANOS CONSERVATION AUTHORITY

A. Incorporation of Standard Code.

Under the terms of the Political Reform Act (Gov't Code §§ 81000 *et seq.*) and regulations promulgated by the FPPC (2 Cal. Code of Regs. §§ 18700, *et seq.*), the Board of Directors is required to adopt a Conflict of Interest Code. The Board of Directors of the Tres Hermanos Conservation Authority incorporates by reference 2 Cal. Code of Regs. § 18730, and its amendments, into this Conflict of Interest Code including, without limitation, the designation of officials and

employees and the disclosure categories set forth below (collectively, "the Conflict of Interest Code").

B. Filing of Statements

The Directors, and their alternates, shall be considered public officials within the meaning of the Political Reform Act of 1974, as amended, and its regulations, for the purposes of financial disclosure, conflict of interest and other requirements of such Act and regulations and shall file annual statements of economic interest as required, along with any other officers of the Authority who may be required to do so with the assigned Filing Officer. After receiving Statements of Economic Interests from Board Members, Filing Officer, must maintain the original record for the Authority files. Other persons working for or on behalf of the Authority may be required to file such statements in accordance with the Authority's conflict of interest code.

Under Government Code § 82011(a), the FPPC is the code reviewing body with respect to the Conflict of Interest Code.

C. Review Procedure

Under Government Code § 87306.5, not later than July 1 of each even numbered year, the Board of Directors must direct the Filing Officer, to review the Conflict of Interest Code. The Filing Officer must submit an amended Conflict of Interest Code to the FPPC if a change in the Conflict of Interest Code is necessitated by changed circumstance. If changes are not required, the Filing Officer must submit a written statement to that effect to the FPPC not later than October 1 of the same year.

D. Designated Positions

The positions attached to this Resolution as Exhibit A entail the making or participation in the making of decisions that may have a foreseeable material effect on the officials or officer's financial interests.

E. Categories of Reportable Economic Interests

Designated positions shall file according to their respective disclosure categories as shown on Exhibit B. Disclosure Category Definitions are outlined on Exhibit C.

F. Disclosure Requirements

Designated employees must disclose all interests as required by the Political Reform Act and regulations promulgated thereto. When a new position classification is created by the Authority, the Executive Director will decide whether the new position will be required to file a Statement of Economic Interest and be included as a designated position in the Conflict of Interest Code.

<u>Section 3.</u> This Resolution will become effective immediately upon adoption.

Section 4. The Secretary shall certify as to the adoption of this Resolution.

EXHIBIT A

CONFLICT OF INTEREST CODE FOR THE TRES HERMANOS CONSERVATION AUTHORITY

The Political Reform Act, Government code Section 81000, et seq., requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 Cal. Code of Reg. Section 18730) that contains the terms of a standard conflict of interest code. It can be incorporated by reference in an agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 Cal. Code of Regs. Section 18730 and any amendment to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. This regulation and the attached Appendix, designating positions and establishing disclosure categories shall constitute the conflict of interest code of the Tres Hermanos Conservation Authority (Authority).

Designated employees shall file statements of economic interests with the Authority who will make the statements available for public inspection and reproduction (Gov. Code Section 81008). Upon receipt of the statements of all designated positions, the Authority shall make and retain a copy and forward the original to the Fair Political Practices Commission.

*Consultants/new positions shall be included in the list of designated positions and shall disclose pursuant to the broadest disclosure category in the code subject to the following limitation:

The Executive Director may determine in writing that a particular consultant or new position, although a "designated position," is hired to perform a range of duties that is limited in scope and thus is not required to comply fully with the disclosure requirements described in this section. Such determination shall include a description of the consultant's or new position's duties and, based upon that description, a statement of the extent of disclosure requirements. The Executive Director's determination is a public record and shall be retained for public inspection in the same manner and location as this conflict-of-interest code (Gov. Code Sec. 81008).

Public Officials Who Manage Public Investments:

The following positions are not covered by the code because the positions manage public investments. Individuals holding such positions must file under Government Code Section 87200 and are listed for informational purposes only. Section 87200 requires disclosure of all investments and business positions in business entities, all income, including gifts, loans and travel payments, and real property.

All investments, business positions in business entities and sources of income (including receipt of gifts, loans and travel payments). Real property located within the jurisdiction as well as real property within two miles of the real property used or the potential site.

Designated Persons in Category "2" Must Report:

Investments and business positions in business entities and sources of income (including receipt of gifts, loans and travel payments) if the business entity or source provides leased facilities, products, equipment, vehicles, machinery or services (including training or consulting services) of the type utilized by the Authority.
