BACKGROUND

Below is a summary of the revenues and expenses for the IPHMA.

DISCUSSION

Staff has budgeted total revenues for the IPHMA in the amount of \$308,000 rental income, and are anticipating \$1,089,000 in expenditures for FY 2023-2024, which are mainly for property and landscape maintenances, general engineering and property maintenance. The shortfall of \$781,000 will be supported by transfers from the City of Industry's General Fund.

FISCAL IMPACT

The FY 2023-24 IPHMA Budget totals \$1,089,000 in expenditures and is supported by \$308,000 in revenues, and a \$781,000 subsidy from the City's General Fund.

The FY 2023-24 Proposed Capital Budget for the IPHMA totals \$1,000,000 and is supported by City funds, as included in the City's FY 2023-24 Adopted CIP Budget.

RECOMMENDATION

Staff recommends that the Board adopt Resolution No. IPHMA 2023-04, adopting the Budget for the Industry Property and Housing Management Authority for Fiscal Year 2023-2024.




