A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF INDUSTRY, CALIFORNIA, RESCINDING ANY AND ALL PRIOR RESOLUTION(S) ESTABLISHING THE ORDER OF THE CITY COUNCIL MEETING AGENDA AND/OR TIME LIMITS FOR ORAL COMMUNICATION, AND ADOPTING RULES REGARDING SAME

RECITALS

WHEREAS, under the Brown Act (Government Code Section 54950 et seq.) the City is required to have an agenda to conduct City Council meetings; and

WHEREAS, pursuant to Government Code Section 54954.3, the City Council is permitted to adopt reasonable regulations limiting the total amount of time allocated for public testimony on particular issues and for each individual speaker; and

WHEREAS, the City Council desires to establish an order for the agenda, and a time limit for pubic testimony for each individual speaker.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF INDUSTRY, CALIFORNIA DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

SECTION 1: The City Council finds that all of the facts set forth in the Recitals are true and correct, and are incorporated herein by reference.

SECTION 2: The City Council hereby rescinds any and all prior Resolution(s) establishing the order of the City Council meeting agenda and/or time limits for oral communications.

SECTION 5: The provisions of this Resolution are severable and if any provision, clause, sentence, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstances, such illegality, invalidity, unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, sections, words or parts thereof of the Resolution or their applicability to other persons or circumstances.

SECTION 6: That the City Clerk shall certify the adoption of this Resolution and that the same shall be in full force and effect.
