BACKGROUND

On October 24, 2019, the City Council approved a License Agreement ("Agreement") with Pacific Crest Youth Aerts Organization ("Pacific Crest") for the use of a portion of the property located at 1123 South Hatcher Avenue, as a storage area for supplies, props, set pieces, vehicles, and various equipment for their programs.

Pacific Crest is a non-profit organization that provides educational and competitive performing arts programs in the greater Southern California region. Pacific Crest has performed at the 2022 Holiday Tree Lighting Ceremony, live stream fundraisers benefiting the La Puente Outreach Food Pantry and Delhaven Community Center, and the Industry Hills Charity Pro Rodeo.

On November 1, 2020, the City Manager granted an extension to the Agreement through November 1, 2021. Amendment No. 1 was approved on October 28, 2021, to extend the Agreement through November 1, 2022. On October 27, 2022, Amendment No. 2 was approved to extend the Agreement through November 1, 2023.

DISCUSSION

Pacific Crest requested to continue to utilize the property. Amendment No. 3 will extend the term for five (5) years through November 1, 2028, and update the City's address. All other terms remain the same, including the City's ability to terminate the Agreement with a 30-day written notice.

FISCAL IMPACT

The lease rate will remain at \$1.00 per year.

RECOMMENDATION

Staff recommends that the City Council approve Amendment No. 3 to the License Agreement with Pacific Crest Youth Arts Organization, dated October 26, 2023.

AMENDMENT NO. 3 TO THE LICENSE AGREEMENT

This Amendment No. 3 to the License Agreement ("Agreement"), is made and entered into this 26th day of October 2023, by and between the City of Industry, a California public body, corporate, and politic ("Licensor/City") and Pacific Crest Youth Arts Organization, a California non-profit corporation ("Licensee") (Licensor and Licensee are individually referred to as "Party" and collectively referred to as the "Parties").

RECITALS

WHEREAS, on or about October 24, 2019, the Agreement was entered into and executed between the Licensor and Licensee, to allow Licensee to use a portion of City owned property located 1123 S. Hatcher Avenue, City of Industry, CA 91748 (APN 8264-004-908), ("Premises"); and

WHEREAS, on or about November 1, 2020, the City Manager granted an extension to the Agreement extending the term through November 1, 2021; and

WHEREAS, on or about October 28, 2021, Amendment No. 1 was approved to extend the term through November 1, 2022; and

WHEREAS, on or about October 27, 2022, Amendment No. 2 was approved to extend the term through November 1, 2023; and

WHEREAS, the Parties desire to amend the License Agreement to extend the term to November 1, 2028 and update the City's address; and

WHEREAS, for the reasons set forth herein, the City and Licensee desire to enter into this Amendment No. 3, as set forth below.

AMENDMENT

NOW, THEREFORE, in consideration of the mutual covenants, promises and agreements set forth herein, it is agreed the aforesaid Agreement and incorporated herein by reference, shall remain in full force and effect except as otherwise hereinafter provided:

Section 9. Term, Termination and Remedies.

The first sentence of Section 9 is hereby revised to read in its entirety as follows:

The License shall commence as of the Effective Date of this Agreement and shall automatically terminate on November 1, 2028.

BACKGROUND

Delhaven Community Center ("Delhaven") is a locally based non-profit organization that works with our community's special needs population, at-risk children, as well as young adults and their families. The organization has been in the community since 1972 and has helped thousands of families with the support services that they offer, including after-school day care, summer camps, free food services, and care for those with special needs.

Delhaven requested permission from the City to utilize the parking lot at the Workman and Temple Homestead Museum to host a fundraising event. The event will take place on December 16, 2023, from the hours of 8 am to 5 pm. The fundraising event will feature a car exhibition, showcasing cars from the Puente Viejo Car Club and vendors offering food and a variety of merchandise. There will also be a holiday toy drive collection benefiting the children in the community.

DISCUSSION

The fundraiser aims to support the children in the community. Those in attendance will donate an unwrapped toy to participate in contests and as entry fee to the event. Vendors selling merchandise will donate their rental space fee to Delhaven. At this time, Staff is requesting the City Council approve the Facilities Use Agreement with Delhaven for use of the parking lot at 15415 Don Julian Road.

FISCAL IMPACT

Given that the event is a fundraiser for a non-profit organization, the City will not charge for the use of the parking lot.

RECOMMENDATION

Staff recommends that the City Council approve the Facilities Use Agreement with Delhaven Community Center, dated October 26, 2023.

CITY OF INDUSTRY FACILITIES USE AGREEMENT

THIS FACILITIES USE AGREEMENT ("Agreement") is entered into on this 26th day of October 2023 ("Effective Date"), by and between the City of Industry, a California municipal corporation (the "City") and Delhaven Community Center, a non-profit organization, (the "User"). The City and User are collectively referred to as "Parties" and individually as "Party".

RECITALS

WHEREAS, the City is the owner of certain real property located at 15415 Don Julian Road, City of Industry, California, (collectively the "Property"), as described in <u>Exhibit A</u>. This Agreement pertains to the non-exclusive use of a portion of the Property; and

WHEREAS, User is a non-profit organization that is conducting a fundraiser serving the community, that desires to use a portion of the Property for its operations; and

WHEREAS, the City desires to allow User to operate at the Property; and

WHEREAS, the Parties desire to enter into this Agreement to make a portion of the Property available to User, as set forth herein.

NOW, THEREFORE, in consideration of the mutual promises, covenants and conditions herein contained, the Parties hereto agree as follows:

GENERAL PROVISIONS

SECTION 1.

(A) Term.

The term of this Agreement shall commence at 7:00 am on December 16, 2023 and shall terminate on 7:00 pm on December 16, 2023, unless sooner terminated by either Party, as provided in this Agreement.

(B) Property.

User may use the designated portion of the Property for the following:

- The User will host a car show fundraiser to support its non-profit mission.
- Vendors will set up booths to sell their merchandise.
- Unwrapped toys will be collected from those attending the event.
- Music will be played by a DJ.

(C) Rent and Utilities.

Given that User is hosting a fundraising event to benefit a non-profit organization, City will donate the space at no cost to User.

(D) Intentionally Left Blank.

(E) Use Restrictions.

User shall only use the Property for the use as described in Section 1(B), above.

(F) User Responsibilities.

- (1) User shall be financially responsible for any damages that may occur at or to the Property related to User's use.
- (2) The User is responsible for the conduct of all participants, the supervision of minors and any damages that may occur at or to the Property related to User's use.
- (3) The User shall require each individual participating in the car show, to execute a release and waiver. The form of the release and waiver shall be in substantially the form attached hereto as Exhibit C, and incorporated herein by reference.
 - (4) Install and remove signs designating parking spaces on the Property.

(G) Non City-Owned Property.

The City reserves the right to remove any items remaining at the expiration of the term of this Agreement from the Property and have them stored at User's expense. If such items, equipment or supplies are not claimed within one (1) week, the City reserves the right to dispose of such material in any manner it deems appropriate. User shall be responsible for any costs of storage and disposal incurred by the City for such equipment or supplies. The City is not responsible for any damage or theft of any items left by User, or any of User's officers, agents, employees, guests, or invitees.

(H) Disclaimer of Condition of Property.

City makes no warranty or representation of any kind concerning the Property or the fitness of the Property for the use intended by User. User has inspected the Property and knows and accepts its condition, and waives any express or implied indemnity against the City.

(I) Damage or Destruction of the Property.

In the event the Property is damaged by fire or other casualty, City may, at its sole and absolute discretion, elect to terminate this Agreement. If the City is unable or unwilling to repair any damage caused by fire or other casualty, User may terminate this Agreement. Should the Property be damaged by fire or other casualty, no liability shall occur against City for damage due to loss of business, loss of revenue or additional costs incurred by User.

(J) Assignment.

User shall not assign this Agreement without the prior written consent of the City. Any such assignment without prior written consent shall be void, and the City, at its option, may terminate this Agreement.

(K) Right of Entry.

City shall be entitled, at all times, to enter the Property for the purpose of inspecting the Property, or for the purpose of inspecting the performance by User of the terms and conditions of this Agreement, or for the purpose of posting and keeping posted thereon notices of non-responsibility for any construction, alteration or repair thereof, as required or permitted by any law or ordinance. City shall also be permitted to use the Property when User is not operating.

SECTION 2. USE OF PREMISES

(A) General.

- i. User shall use the Property as provided Section 1(B) above.
- ii. User shall not use the Property, or any portion thereof, for any purpose which may increase the existing rate of insurance upon the Property, or cause the cancellation of the insurance on the Property. User shall be responsible for any insurance increase or cancellation of insurance, as a result of its activities at the Property.

(B) Hours of Operation.

User shall maintain the following hours of operation: 7:00 am to 7:00 pm on December 16, 2023.

(C) Supplies and Expenses.

- i. User shall be responsible for the costs associated with liability insurance for its use of the Property.
- ii. User shall pay for all equipment (collectively, "Equipment") used for its activities on the Property.

(D) Maintenance, Repair and Alterations.

i. City shall be responsible for any structural, routine maintenance, and long term capital repair at the Property, except to the extent such repair is made necessary as a result of the misconduct or negligent acts or omissions of User, its participants, staff, volunteers, and/or invitees. In the event of any repair, whether requested by User or otherwise, the City may make the determination whether to do the work or terminate this Agreement. Notwithstanding the foregoing, the City shall not be responsible for any structural or routine maintenance to the Equipment operated by the User, which shall be the sole and absolute responsibility of the User.

- ii. City shall be responsible for maintaining all landscaping at the Property.
- iii. User shall maintain the Property in good and safe condition, and shall be responsible for repairing any damage arising from the negligence or misconduct of User, its participants, staff, volunteers, and/or invitees. In the event User discovers a hazard or maintenance issue at the Property, it shall immediately notify the City in writing or via email.
- iv. User shall not commit, or suffer to be committed, any waste upon the Property, or any public or private nuisance.
- v. User shall not make any improvements to the Property during the Term of this Agreement..
- vi. The User shall not cause or permit to be filed, recorded or enforced against the Property, or any part thereof, any mechanics', material men's, contractors' or subcontractors' liens arising from the uses permitted herein, or any claim or action affecting the title to the Property arising from the uses permitted herein, and the User shall pay or cause to be paid, or otherwise removed or bonded over, the full amount of all such liens or claim within fifteen (15) days of receiving written notice thereof. In addition to and not in limitation of the City's other rights and remedies under this Agreement or under law, should the User fail within fifteen (15) business days of a written notice from the City to pay and discharge or bond over any lien arising out of the User's use of the Property, then a material breach under this Agreement shall be deemed to have occurred which, at the City's election, shall entitle the City to terminate this Agreement effective upon notice by the City to the User so stating.

If the User desires to contest in good faith the validity of any lien or any claim or demand that could result in a lien against the Property or any portion thereof for which the City could become liable if not successfully resolved, as a condition to such contest, the User shall notify the City of the User's intent to contest the lien or claim and the grounds for such contest. Notwithstanding anything to the contrary set forth herein, the User shall pay and satisfy any adverse judgment that may be rendered thereon before the enforcement thereof against the City or the Property.

SECTION 4. RELEASE, HOLD HARMLESS AND INDEMNIFICATION

- (A) User shall defend, indemnify, and hold harmless City, its elected and appointed officers, officials, agents, contractors, attorneys, consultants, employees and volunteers from and against any and all claims, damages, demands, liability, costs, losses and expenses, including without limitation court costs and reasonable attorneys' fees, arising out of or in connection with User's use of the Property, or its negligent failure to comply with any of its obligations contained in this Agreement (collectively "Claims"). Acceptance by City of insurance certificates and endorsements required under this Agreement does not relieve User from liability under this indemnification and hold harmless clause. This indemnification and hold harmless clause shall apply to any Claims whether or not such insurance policies shall have been determined to apply.
- (B) User releases the City, its officers, officials, attorneys, agents, and employees of any and all claims, damages, demands, liability, costs, losses and expenses, including without limitation court costs and reasonable attorney's fees, arising out of or in connection with User's use of the Property under this Agreement.

User acknowledges and expressly waives the benefit of California Civil Code Section 1542, which is set forth below, and specifically agrees that the release contained in this Agreement shall extend to all claims arising out of transactions which the Parties do not know or expect to exist in their favor at this time, and which rise out of or are connected to the Agreement. California Civil Code Section 1542 provides:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

User acknowledges that the facts and law in relation to this matter and the claims released by the terms of this Agreement may turn out to be different from or in addition to the facts or law as now known to each Party or its counsel. User therefore expressly agrees that the release so given shall be and remain in effect as a full and complete release of the persons and entities released thereby notwithstanding any possibility of new or different facts or law.

- **(C)** By execution of this Agreement, User acknowledges and agrees to the provisions of this Section and that it is a material element of consideration.
- **(D)** If, for any reason such as, but not limited to, earthquake, flood water damage, explosion or other calamity of circumstance, it shall become necessary to close the Property, no liability shall occur against City for damage due to loss of business, loss of revenue or additional costs incurred by User.

SECTION 5. INSURANCE

- (A) During the term of this Agreement, User shall, at its sole costs and expense, carry, maintain, and keep in full force and effect insurance of the types and in the amounts as set forth in the attached Exhibit B, incorporated herein by this reference.
- **(B)** City and its elected and appointed officers, employees, attorneys, agents, and volunteers shall be named as additional insureds with respect to each of the insurance policies required under this Agreement.
- (C) At all times during the term of this Agreement, User shall maintain on file with the City's City Clerk a certificate or certificates of insurance showing that the insurance policies required by this Section 5 are in effect in the required amounts and naming the City and its elected and appointed officers, employees, attorneys, agents, and volunteers as additional insureds. User shall, concurrently with the execution of this Agreement, file with City's City Clerk such certificate(s).

(D) User shall provide proof that policies of insurance required herein expiring during the term of this Agreement have been renewed or replaced with other policies providing at least the same coverage. Such proof will be furnished at least two weeks prior to the expiration of the coverages.

<u>SECTION 6.</u> <u>INDEPENDENT CONTRACTOR</u>

- (A) User is and shall at all times remain as to the City a wholly independent consultant and/or independent contractor. The personnel performing the services under this Agreement on behalf of User shall at all times be under User' exclusive direction and control. Neither City nor any of its officers, employees, attorneys, or agents shall have control over the conduct of User or any of User officers, employees, or agents, except as set forth in this Agreement. User shall not at any time or in any manner represent that it or any of its officers, employees, or agents are in any manner officers, employees, or agents of the City. User shall not incur or have the power to incur any debt, obligation, or liability whatever against the City, or bind the City in any manner.
- (B) No employee benefits shall be available to User in connection with the performance of this Agreement. City shall not pay salaries, wages, or other compensation for operating User. City shall not be liable for compensation or indemnification to User for injury or sickness arising out of its operation or use of the Property under this Agreement.
- (C) User shall indemnify, defend and hold harmless, the City, its officers, employees, attorneys, and agents, from and against any liability (including liability for claims, suits, actions, arbitration proceedings, administrative proceedings, regulatory proceedings, losses, expenses or costs of any kind, whether actual, alleged or threatened, including contributions to any retirement and/or pension plan, legal counsel fees and costs, court costs, interest, defense costs, and expert witness fees), where the same arise out of, are a consequence of, or are in any way attributable to, in whole or in part, User or by any individual or agency for which User is legally liable, including but not limited to officers, agents, employees or subconsultants of User, service as an independent contractor. The indemnity provisions set forth in this Section 6 shall survive the termination of this Agreement and are in addition to any other rights or remedies the City may have under the law.

SECTION 7. NOTICES

Any notices which either Party may desire to give to the other Party under this Agreement must be in writing and may be given either by (i) personal service, (ii) delivery by a reputable document delivery service, such as but not limited to, Federal Express, which provides a receipt showing date and time of delivery, or (iii) mailing in the United States Mail, certified mail, postage prepaid, return receipt requested, addressed to the address of the party as set forth below or at any other address as that party may later designate by notice:

SECTION 8. COMPLIANCE WITH LAWS

User represents and warrants to City that User, its officers, agents, employees and volunteers have all licenses, permits, qualifications, and approvals of whatever nature which are legally required for User, its officers, agents, employees and volunteers to provide the services, programs and activities contemplated by this Agreement, and that it shall comply with all statutes, ordinances, regulations, and requirements of all governmental entities, federal, state, county and city, relating to its actions under this Agreement whether such statutes, ordinances, regulations and requirements are now in force or hereinafter enacted.

SECTION 9. DEFAULT/TERMINATION

- (A) In the event of any breach of this Agreement, City, in addition to any other rights and remedies it may have, shall have the immediate right of re-entry and may remove all persons and property from the Property.
- **(B)** In the event of any breach of this Agreement, either Party may terminate the Agreement immediately, by serving written notice upon the other. Upon receipt of said notice, User shall immediately vacate the Property and remove all of its possessions.
- (C) User may at any time, for any reason, with or without cause, suspend or terminate this Agreement, or any portion hereof by serving the City with five days' written notice. City may at any time, for any reason, with or without cause, suspend or terminate this Agreement, or any portion hereof by serving the User with notice 24 hours prior to termination. Upon receipt of said notice, User shall have 24 hours to vacate the Property and remove all of its possessions, unless the notice provides otherwise. If either Party suspends or terminates a portion of this Agreement such suspension or termination shall not make void or invalidate the remainder of this Agreement.

SECTION 10. MISCELLANEOUS PROVISIONS

(A) User acknowledges that this Agreement may create a possessory interest subject to property taxation, and that User may be subject to payment of property taxes levied on such interest. Any such tax liability shall be the sole and exclusive responsibility of User.

- **(B)** User agrees that its use of the Property and this Agreement, shall not entitle User to any relocation benefits pursuant to federal, state, or local law, and User hereby waives any such claim against the City for relocation benefits.
- (C) The rights granted to User under this Agreement are non-exclusive use only, and in no respect shall the same constitute or be construed as an assignment of a leasehold or other interest in the Property set forth in this Agreement.
- (D) Each right, power and remedy provided for herein or now or hereafter existing at law, in equity, by statute, or otherwise shall be cumulative and shall be in addition to every other right, power, or remedy provided for herein or now or hereafter existing at law, in equity, by statute, or otherwise. The exercise, the commencement of the exercise, or the forbearance of the exercise by any party of any one or more of such rights, powers or remedies shall not preclude the simultaneous or later exercise by such party of any of all of such other rights, powers or remedies.
- (E) If any action at law or suit in equity is brought to enforce or interpret the provisions of this Agreement, or arising out of or relating to User use of the Property under this Agreement, the prevailing party shall be entitled to reasonable attorneys' fees and all related costs, including costs of expert witnesses and consultants, as well as costs on appeal, in addition to any other relief to which it may be entitled. The venue for any litigation shall be Los Angeles County, California or in the United States District Court for the Central District of California.
- (F) If any term or provision of this Agreement or the application thereof to any person or circumstance shall, to any extent, be invalid or unenforceable, then such term or provision shall be amended to, and solely to, the extent necessary to cure such invalidity or unenforceability, and in its amended form shall be enforceable. In such event, the remainder of this Agreement, or the application of such term or provision to persons or circumstances other than those as to which it is held invalid or unenforceable, shall not be affected thereby, and each term and provision of this Agreement shall be valid and be enforced to the fullest extent permitted by law.
- **(G)** This Agreement shall be governed and construed in accordance with the laws of the State of California without regard to principles of conflicts of laws.
- **(H)** All documents referenced as exhibits in this Agreement are hereby incorporated in this Agreement. In the event of any material discrepancy between the express provisions of this Agreement and the provisions of any document incorporated herein by reference, the provisions of this Agreement shall prevail.
- (I) This instrument contains the entire Agreement between the City and User with respect to the transactions contemplated herein. No other prior oral or written agreement(s) are binding upon the Parties. Amendments hereto or deviations herefrom shall be effective and binding only if made in writing and executed by City and User.
- (J) This Agreement may be executed simultaneously in multiple counterparts, each of which shall be deemed an original, but all of which taken together shall constitute one and the same instrument.

User may use the designated portion of the Property identified in the map below by yellow lines.




Exhibit B

INSURANCE REQUIREMENTS

Without limiting User indemnification of City, and prior to commencement of the Services, User shall obtain, provide and maintain at its own expense during the term of this Agreement, policies of insurance of the type and amounts described below and in a form satisfactory to the City.

General liability insurance. User shall maintain commercial general liability insurance with coverage at least as broad as Insurance Services Office form CG 00 01, in an amount not less than \$1,000,000.00 per occurrence, \$2,000,000.00 general aggregate, for bodily injury, personal injury, and property damage. The policy must include contractual liability that has not been amended. Any endorsement restricting standard ISO "insured contract" language will not be accepted.

Automobile liability insurance. User shall maintain automobile insurance at least as broad as Insurance Services Office form CA 00 01 covering bodily injury and property damage for all activities of User arising out of or in connection with this Agreement, including coverage for any owned, hired, non-owned or rented vehicles, in an amount not less than \$1,000,000.00 combined single limit for each accident.

Workers' compensation insurance. User shall maintain Workers' Compensation Insurance (Statutory Limits) and Employer's Liability Insurance (with limits of at least \$1,000,000.00).

User shall submit to City, along with the certificate of insurance, a Waiver of Subrogation endorsement in favor of the City, its officers, agents, employees and volunteers.

Proof of insurance. User shall provide certificates of insurance to City as evidence of the insurance coverage required herein, along with a waiver of subrogation endorsement for workers' compensation. Insurance certificates and endorsement must be approved by the City prior to commencement of performance. Current certification of insurance shall be kept on file with City at all times during the term of this contract. City reserves the right to require complete, certified copies of all required insurance policies, at any time.

Duration of coverage. User shall procure and maintain for the duration of the contract insurance against claims for injuries to persons or damages to property, which may arise from or in connection with this Agreement by User, its agents, representatives, employees or subconsultants.

Primary/noncontributing. Coverage provided by User shall be primary and any insurance or self-insurance procured or maintained by City shall not be required to contribute with it. The limits of insurance required herein may be satisfied by a combination of primary and umbrella or excess insurance. Any umbrella or excess insurance shall contain or be endorsed to contain a provision that such coverage shall also apply on a primary and non-contributory basis for the benefit of City before the City's own insurance or self-insurance shall be called upon to protect it as a named insured.

City's rights of enforcement. In the event any policy of insurance required under this Agreement does not comply with these specifications or is canceled and not replaced, City has the right but not

the duty to obtain the insurance it deems necessary and any premium paid by City will be promptly reimbursed by User. In the alternative, City may cancel this Agreement.

Acceptable insurers. All insurance policies shall be issued by an insurance company currently authorized by the Insurance Commissioner to transact business of insurance in the State of California, with an assigned policyholders' Rating of A- (or higher) and Financial Size Category Class VI (or larger) in accordance with the latest edition of Best's Key Rating Guide, unless otherwise approved by the City's Risk Manager.

Waiver of subrogation. All insurance coverage maintained or procured pursuant to this agreement shall be endorsed to waive subrogation against City, its elected or appointed officers, agents, officials, employees and volunteers or shall specifically allow User or others providing insurance evidence in compliance with these specifications to waive their right of recovery prior to a loss. User hereby waives its own right of recovery against City, and shall require similar written express waivers and insurance clauses from each of its subconsultants.

Enforcement of contract provisions (non estoppel). User acknowledges and agrees that any actual or alleged failure on the part of the City to inform User of non-compliance with any requirement imposes no additional obligations on the City nor does it waive any rights hereunder.

Requirements not limiting. Requirements of specific coverage features or limits contained in this Section are not intended as a limitation on coverage, limits or other requirements, or a waiver of any coverage normally provided by any insurance. Specific reference to a given coverage feature is for purposes of clarification only as it pertains to a given issue and is not intended by any party or insured to be all inclusive, or to the exclusion of other coverage, or a waiver of any type. If User maintains higher limits than the minimums shown above, the City requires and shall be entitled to coverage for the higher limits maintained by User. Any available insurance proceeds in excess of the specified minimum limits of insurance and coverage shall be available to the City.

Notice of cancellation. User agrees to oblige its insurance agent or broker and insurers to provide to City with a five (5) day notice of cancellation or nonrenewal of coverage for each required coverage.

Additional insured status. General liability policies shall provide or be endorsed to provide that City and its officers, officials, employees, and agents, and volunteers shall be additional insureds under such policies. This provision shall also apply to any excess liability policies.

Prohibition of undisclosed coverage limitations. None of the coverages required herein will be in compliance with these requirements if they include any limiting endorsement of any kind that has not been first submitted to City and approved of in writing.

Separation of Insureds. A severability of interests provision must apply for all additional insureds ensuring that User insurance shall apply separately to each insured against whom claim is made or suit is brought, except with respect to the insurer's limits of liability. The policy(ies) shall not contain any cross-liability exclusions.

Pass Through Clause. User agrees to ensure that its subconsultants, subcontractors, and any other party involved with the permitted use who is brought onto or involved in the permitted use by User, provide the same minimum insurance coverage and endorsements required of User. User agrees to

monitor and review all such coverage and assumes all responsibility for ensuring that such coverage is provided in conformity with the requirements of this section. User agrees that upon request, all agreements with consultants, subcontractors, and others engaged in the project will be submitted to City for review.

City's right to revise specifications. The City reserves the right at any time during the term of the contract to change the amounts and types of insurance required by giving User five (5) days advance written notice of such change.

Self-insured retentions. Any self-insured retentions must be declared to and approved by the City. The City reserves the right to require that self-insured retentions be eliminated, lowered, or replaced by a deductible. Self-insurance will not be considered to comply with these specifications unless approved by the City.

Timely notice of claims. User shall give the City prompt and timely notice of claims made or suits instituted that arise out of or result from User performance under this Agreement, and that involve or may involve coverage under any of the required liability policies.

Additional insurance. User shall also procure and maintain, at its own cost and expense, any additional kinds of insurance, which in its own judgment may be necessary for its proper protection and prosecution of this Agreement.

WAIVER, RELEASE, HOLD HARMLESS AND AGREEMENT NOT TO SUE

In consideration for being permitted to participate in the Delhaven car show, I hereby agree, for myself, my heirs, administrators, executors and assigns, that I shall indemnify and hold harmless the City of Industry, its elected and appointed officers, officials, agents, contractors, consultants, employees and volunteers from any and all claims, demands actions or suits arising out of or in connection with my participation in the Delhaven fundraising event.
I HAVE CAREFULLY READ THIS RELEASE, HOLD HARMLESS AND AGREEMENT NOT TO SUE AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT IT IS A FULL RELEASE OF ALL LIABILITY AND SIGN IT ON MY OWN FREE WILL.

DISCUSSION

Due to the fact that the November 23, 2023, regular City Council Meeting falls on Thanksgiving Day, Staff recommends canceling this meeting. Staff also recommends canceling the December 28, 2023, regular City Council Meeting since it occurs during the week between Christmas and New Year's Day.

Additionally, in observance of the Christmas and New Year holidays, Staff recommends closing City Hall from December 22, 2023, through January 1, 2024, and reopening on Tuesday, January 2, 2024.

RECOMMENDATION

Staff recommends canceling the November 23, 2023, and December 28, 2023, regular City Council Meetings and closing City Hall from December 22, 2023, through January 1, 2024.

SETTLEMENT AGREEMENT AND RELEASE

THIS SETTLEMENT AGREEMENT AND RELEASE ("Agreement") is made and entered into by and between CITY OF INDUSTRY ("City"), on the one hand, and ABRAHAM N. CRUZ ("Cruz"), on the other hand, in accordance with the terms and conditions set forth below. The City and Cruz will be collectively referred to as the "Parties."

RECITALS

- A. The City is a municipal corporation and charter city existing under the laws of the State of California, and is located in the County of Los Angeles.
- B. Cruz is an individual and former Councilmember for the City. Cruz was initially appointed to the City Council in 2015.
- C. On December 8, 2020, Cruz filed a Complaint against the City of Industry and several other defendants in the action entitled *Abraham Cruz v. Mark Radecki, et al.*, Los Angeles Superior Court Case No. 20STCV47002 ("<u>Cruz Lawsuit</u>"). The City, together with defendants Mark Radecki, Cory Moss, Newell Ruggles, Michael Greubel, Catherine Marcucci, and Industry Property and Housing Management Authority, prevailed in the Cruz Lawsuit and were awarded costs by the Court on November 1, 2021, in the amount of \$931.35.
- D. On July 8, 2020, the City filed a Complaint against Cruz in the action entitled *City of Industry v. Abraham Cruz*, Los Angeles Superior Court Case No. 20STCV25407 ("<u>Lawsuit</u>"). In the Complaint, the City alleges Cruz violated his fiduciary and legal duties to the City by unlawfully disclosing confidential closed session information during his tenure on the City Council, in violation of Government Code section 54963.
- E. Cruz denies the allegations in the City's Complaint and disputes the City's entitlement to relief in the Lawsuit.
- F. The City and Cruz now desire to resolve the Lawsuit and the costs amount owed in the Cruz Lawsuit.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. <u>Recitals</u>. The Parties agree that the recitals set forth above are true and correct and are incorporated herein by this reference.

- 2. <u>Declaration by Cruz</u>. As a condition precedent to this Agreement, Cruz shall execute, under penalty of perjury, and deliver to the City, the declaration attached hereto as Exhibit A (the "<u>Cruz Declaration</u>"). To induce the City to enter into this Agreement, Cruz hereby certifies and agrees that the information stated in the Cruz Declaration is true and correct and that he is not withholding any relevant information regarding the same. Any misrepresentation or omission in the Cruz Declaration shall constitute a material breach of this Agreement. Cruz further agrees that the City may use the Cruz Declaration at its discretion.
- 3. <u>Settlement Payment by Cruz</u>. Cruz agrees to pay the City, and the City agrees to accept, the total sum of Nine Hundred Thirty-One Dollars and Thirty-Five Cents (\$931.35) (the "<u>Settlement Payment</u>"), in settlement of the City's claims in the Lawsuit and to the costs owed to the City in the Cruz Lawsuit. The Settlement Payment shall be paid by check, made payable to the City of Industry and delivered to the following address no later than 5 court days after this Agreement and the Cruz Declaration are fully executed and delivered to the City:

- 4. <u>Dismissal of Action; Satisfaction of Judgment</u>. Within 10 court days after receipt of the Settlement Payment, the City shall (a) file a Request for Dismissal, without prejudice, of its Complaint against Cruz in the Action, and (b) file an Acknowledgment of Satisfaction of Judgment in the Cruz Lawsuit with respect to the outstanding costs amount.
- 5. Release by the City. The City hereby releases and forever discharges Cruz from all claims, causes of action, and liability under Government Code section 54963, which the City has, or may have had, against Cruz. The City's agreement to execute this release, and the release itself, is conditioned on the truthfulness of the Cruz Declaration. This release shall not affect Cruz's ongoing obligations under Government Code section 54963 or the City's right to seek legal or equitable relief if the City learns facts demonstrating that Cruz has disclosed, or will disclose, confidential information in violation of Government Code section 54963.
- 6. Release by Cruz. Cruz, on behalf of himself, hereby releases and forever discharges the City, as well as its past and present departments, boards, commissions, Council members, officials, officers, employees, consultants, managers, contractors, agents, corporate affiliates (including any corporations, companies, and partnerships that City controls or owns), successors, predecessors, administrators, trusts, trustees, trustors, beneficiaries, assigns, insurers, reinsurers, attorneys (including, but not limited to, Casso & Sparks, LLP and its current and former partners, associates, and employees), and representatives (collectively, the "City Released Parties"), from all claims, causes of action, and liability, whether at law or in equity, arising out of

the Lawsuit, which Cruz has, or may have had, against the City Released Parties, whether or not apparent or yet to be discovered, or which he may hereafter develop.

7. <u>California Civil Code Section 1542</u>. The Parties certify that they have read the provisions of California Civil Code Section 1542 and have consulted their own counsel regarding that section, which states as follows:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

The Parties hereby expressly waive and relinquish all rights and benefits under California Civil Code section 1542 with respect to the releases provided above.

- 8. Exclusion of Claims from Releases. Nothing in paragraphs 5, 6, and 7, or any other provision of the Agreement, is intended to release (1) any claim related to or arising from enforcement of this Agreement and (2) any claim the City has, or may have, against Cruz, relating to any violations of Government Code section 54963 that are not disclosed in the Cruz Declaration or any future violations of Government Code section 54963.
- 9. <u>No Assignment of Claims</u>. Each Party represents and warrants that it is the rightful owner of and has not encumbered, assigned, or transferred, nor will it in the future attempt to encumber, assign, or transfer, any claim for relief or cause of action released herein.
- 10. Advice of Counsel. In entering into this Agreement, each Party acknowledges that: (1) it has had the opportunity to seek and rely upon the legal advice of attorneys of its own choosing; (2) it fully understands and voluntarily accepts the Agreement's terms based on the consideration set forth in this Agreement and not on any other promises or representations by the other Party or any attorney or other agent or representative of the other Party; and (3) in deciding to sign this Agreement, it did not rely and has not relied on any oral or written representation or statement by the other Party or any attorney, or other agent or representative of the other Party, including, but not limited to, any representation or statement about the subject matter, basis, or effect of this Agreement.
- 11. <u>Authority</u>. Each Party represents and warrants that it has full authority to enter into, deliver, and perform under this Agreement, and that all acts and actions have been taken to grant such authority, and that no third-party consent, which has not already been obtained, is required. Each signatory to this Agreement represents and warrants that it is authorized to execute this Agreement on behalf of the Party for whom it executed this Agreement.

- 12. **Binding Agreement; Successors and Assigns**. The Parties intend this Agreement to be legally binding upon and shall inure to the benefit of each of them and their respective parents, subsidiaries, affiliates, predecessors, successors, assigns, executors, administrators, heirs, and estates.
- 13. <u>Further Cooperation</u>. Each Party agrees to take all actions and to make, deliver, sign, and file any other documents and instruments necessary to carry out the terms, provisions, purpose, and intent of this Agreement.
- 14. <u>No Admissions of Liability</u>. The Parties acknowledge that this Agreement represents a compromise and final settlement of disputed claims and agree that the performance of the conditions and provisions of this Agreement, including the payment and acceptance of the Settlement Payment, is not to be construed as an admission of any liability or wrongdoing whatsoever by any Party to this Agreement.
- 15. <u>Attorneys' Fees and Costs</u>. Except as provided for in this Agreement, each Party will bear their own attorneys' fees and costs of suit. However, if any Party brings a legal action to enforce or interpret this Agreement, the prevailing Party shall recover, in addition to any other relief, its reasonable attorneys' fees and costs incurred in such action.
- 16. <u>Choice of Law</u>. This Agreement and all related documents, including all exhibits attached hereto, and all matters arising out of or relating to this Agreement, whether sounding in contract, tort, or statute are governed by, and construed in accordance with, the laws of the State of California (including its statutes of limitation), without giving effect to the conflict of laws provisions thereof to the extent such principles or rules would require or permit the application of the laws of any jurisdiction other than those of the State of California.
- 17. Choice of Forum. Any claim or action arising out of or relating to this Agreement, or an alleged breach thereof, shall be brought in the state or federal courts of California located in Los Angeles, in accordance with paragraph 16 of the Agreement. Should any such action or other proceeding be brought, the prevailing party shall be entitled to recover reasonable attorneys' fees and costs, including post-judgment attorneys' fees and costs, incurred in connection with that claim or action.
- 18. <u>Notices</u>. Notices required to be sent under this Agreement shall be sent by email or U.S. mail to the Parties at the following addresses:

The Parties expressly waive any common law or statutory rule of construction that any ambiguities or uncertainties should be construed against the drafter of this Agreement, including, but not limited to, California Civil Code section 1654.
- 20. **Pronouns.** All pronouns and any variations thereof shall be deemed to refer to the masculine, feminine, neuter, singular or plural, as the identity of the person or entity may require.
- 21. <u>Headings</u>. The headings within this Agreement are for the purpose of reference only and shall not limit or otherwise affect any of the terms of this Agreement.

- 22. <u>Severability of Provisions</u>. Should any provision of this Agreement be declared or be determined by any court to be illegal, invalid, or unenforceable, the validity of the remaining parts, terms, or provisions shall not be affected thereby and the illegal, invalid, or unenforceable part, term, or provision shall be deemed not to be a part of this Agreement.
- 23. <u>Entire Agreement</u>. This Agreement, including the recitals and all exhibits attached hereto, constitutes the entire agreement and understanding of the Parties and supersedes all prior negotiations and/or agreements, proposed or otherwise, written or oral, concerning the subject matter hereof. Each Party acknowledges that in entering into this Agreement, it has not relied on any promise, representation, or warranty not contained in this Agreement.
- 24. <u>Waiver</u>. No waiver of any provision of this Agreement shall be binding unless executed in writing and signed by a representative of the party making the waiver, and such executed written waiver shall not be deemed and shall not constitute either a waiver of any other provision of this Agreement or a continuing waiver.
- 25. <u>Modification</u>. No modification of this Agreement shall be binding unless in writing and signed by each of the Parties hereto.
- 26. **Counterparts.** This Agreement may be executed in one or more counterparts, each of which when so executed shall be deemed to be an original, but all of which when taken together shall constitute one and the same instrument. If this Agreement or any document executed in connection with the Agreement, including the Cruz Declaration, is transmitted by telecopy, emailed ".pdf," ".tif," or any other electronic means that reproduces an image of the actual executed signature page it shall be effective as delivery of a manually executed counterpart of such document and shall constitute a covenant to deliver an executed original counterpart, but the failure to do so shall not affect the validity, enforceability, and binding effect of such document. The words "execution," "signed," "signature," "delivery," and words of like import in or relating to any document to be signed in connection with the Agreement shall be deemed to include electronic signatures, deliveries, or the keeping of records in electronic form, each of which shall be of the same legal effect, validity, or enforceability as a manually executed signature, physical delivery thereof or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the California Uniform Electronic Transactions Act, or any other similar state laws based on the Uniform Electronic Transactions Act.
- 27. <u>Effective Date</u>. This Agreement will be effective as of the date that all documents required by the Agreement are executed and exchanged between the Parties.

Background:

On December 2, 2021, the Los Angeles County Metropolitan Transportation Authority Board ("LACMTA Board") approved the Open Streets Cycle 4 Grant Program providing Los Angeles County Proposition C Funds ("Grant Funds") for events that temporarily close the street to automotive traffic and open them to pedestrians, cyclists, and demonstrations intending to make the streets safer for both pedestrians and motorists. The LACMTA Board approved the San Gabriel Valley Council of Governments ("SGVCOG") to serve as the pass-through agency of the Proposition C Funds with its member cities, and SGVCOG was successful in securing \$500,000.00 in Grant Funds during Cycle 4 from the LACMTA Board for the SGV Slower, Safer Streets Program. SGVCOG member cities were invited to apply to SGVCOG for Grant Funds of up to \$50,000.00 for eligible projects under the SGV Slower, Safer Streets Program. The City applied for \$40,000.00 in Grant Funds to support hosting a Slow Street Demonstration at the intersection of Nelson Avenue and Willow Avenue in the City ("Demonstration").

On July 28, 2022, the City approved a Memorandum of Agreement ("MOA") with the San Gabriel Valley Council of Governments to award funding from the SGV Slower Safer Streets Program. On February 6, 2023 the City approved Amendment No. 1 to award funding from the San Gabriel Valley Slower, Safer Streets Program.

On July 13, 2023, the City approved Amendment No. 2 to extends the term through October 31, 2023.

Staff worked with SGVCOG on preparation of an Implementation Plan for the project. The plan outlined the steps involved in carrying out the Demonstration from initial design, developing a schedule, to installing and project closeout. The Implementation Plan was reviewed and approved by SGVCOG on December 8, 2022.

Discussion:

After review of the City's application, the SGVCOG determined that the Demonstration is eligible for an award in an amount not-to-exceed \$40,000.00 in Grant Funds for those reimbursable expenses described in Exhibit A. The Demonstration entails installing a Rectangular Rapid Flashing Beacon ("RRFB") for the existing crosswalk at Nelson Avenue and Willow Avenue, an unsignalized intersection. Currently, there are only static advance signs. The RRFB will be pedestrian actuated and solar powered. This Demonstration will enhance the safety of both the vehicular and pedestrian traffic. The City will fund the Demonstration up front and thereafter be reimbursed 80 percent by SGVCOG, up to \$40,000.00, due to the condition of the Grant Funds, that the City is required to provide a minimum 20 percent contribution of the project costs.

The term of the Agreement is from August 17, 2022 to October 31, 2023. This Third Amendment extends the term through December 1, 2023. Additionally, it amends the temporary installation tasks to add full street closure requirements for a minimum of two street closure events, data collection using Metro's Standardized Data Collection Template and Communication materials to be approved by SGVCOG and Metro before public demonstration. Staff expects the additional costs to be less than \$5,000.00 for the two street closures.

Fiscal Impact:

The fiscal impact associated with Amendment No. 3 is estimated to be less than \$5,000.00. This is budgeted in the adopted Fiscal Year 23-24 Capital Improvement Project budget (Account No. 120-702-5205, MP 22-19).

Recommendation:

Staff recommends approval of Amendment No. 3 to the Memorandum of Agreement.

MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE SAN GABRIEL VALLEY COUNCIL OF GOVERNMENTS AND THE CITY OF INDUSTRY TO AWARD FUNDING FROM THE SGV SLOWER SAFER STREETS PROGRAM

This Third Amendment to the Memorandum of Agreement ("Third Amendment") is made and entered into as of October 26, 2023, by and between the San Gabriel Valley Council of Governments, a California joint powers agency ("SGVCOG"), and the City of Industry, a municipal corporation (herein referred to as the "City") with reference to the following:

- A. The SGVCOG and the City entered into that certain Memorandum of Agreement dated as of July 28, 2022, which is incorporated herein by this reference (the "Original Agreement"); and
- B. The SGVCOG and the City entered into that certain First Amendment to the Original Agreement dated as of February 22, 2023, and the Second Amendment dated July 13, 2023, which are collectively incorporated herein by the reference (the "Amendments"), which Amendments and Original Agreement collectively are referred to as the "Agreement"; and
- C. The SGVCOG and the City desire to amend the Agreement to modify, amend and supplement certain portions thereof.

NOW, THEREFORE, the parties hereby agree as follows:

- 1. **Defined Terms.** Except as otherwise defined herein, all capitalized terms used herein shall have the meanings set forth for such terms in the Agreement.
- **2.** Revised Scope of Work. The Scope of Work, Exhibit "A" to the Agreement, is hereby deleted and replaced in its entirety with the Scope of Work described in Exhibit "A" attached hereto and incorporated herein by this reference.
- **3. Term.** The Term of the Agreement as set forth in Section 2 therein is from September 30, 2023 to October 31, 2023. This Third Amendment extends the Term up to and including December 1, 2023.
- 4. Integration. This Third Amendment and all attachments hereto (if any) integrate all of the terms and conditions mentioned herein, and supersede all negotiations with respect hereto. This Third Amendment amends, as set forth herein, the Agreement and except as specifically amended hereby, the Agreement shall remain in full force and effect. To the extent that there is any conflict or inconsistency between the terms and provisions of this Third Amendment and the terms and provisions of the Agreement, the terms and provisions of this Third Amendment shall control.

San Gabriel Valley Council of Governments (SGVCOG) San Gabriel Valley Slower, Safer Street Program Implementation Plan for City of Industry (City) Slow Street Demonstration Project

<u>Demonstration Location:</u> The Demonstration will be located at the intersection of Nelson Avenue and Willow Avenue in the City. The Demonstration is located on the border of the City and the City of La Puente, with Nelson Avenue acting as the dividing line between the two cities. There is an Adult Learning Center on the north side of the Nelson Avenue (City of La Puente) and commercial/industrial businesses on the south side of Nelson Avenue (City of Industry).

Event Description: The City will purchase and demonstrate the use of a solar powered Rectangular Rapid Flashing Beacon (RRFB) at an existing un-signalized intersection of Nelson Avenue and Willow Avenue. The demonstration will increase crosswalk visibility, slow down oncoming vehicular traffic, improve safety and encourage active forms of transit.

<u>Implementation Plan:</u> The following is a breakdown of the sequence of tasks, including budget and schedule, needed to implement the demonstration.

Planning and Engineering Tasks:

- 1. Identify Location for Demonstration: This task has already been completed.
- 2. Field Review to identify any constraints: This will involve a site visit to the location document the existing conditions, including any that impact the layout or location of the RRFB. The field review will include photo documentation of the existing conditions.
- 3. Research available devices: Research will be performed to determine which traffic equipment manufacturers provide RRFB's. In addition, research will need to be done to determine the proper solar panel size, configuration and support equipment to provide power to the RRFB.
- 4. Identify additional safety measures to incorporate: In addition to the installation of he RRFB device, the existing conditions of the location as well as the pedestrian and vehicular movements will be evaluated to determine if additional safety measurement need to be incorporated to supplement the RRFB.

Engineering Tasks:

- 5. Preparation of Base Map: A topographic map will be prepared to properly locate all existing surface features that may impact the location of the RRFB, sight distance for approaching vehicles and visibility to the crosswalk.
- 6. Prepare conceptual layout of devices, signage and any additional safety measures: Once the base map has been completed and the specific RRFB and solar panel devices have been selected, a conceptual layout plan will be prepared.
- 7. Coordinate with and obtain approval of conceptual layout from the City of La Puente: Since the project location straddles the boundary between the Cities of Industry and La Puente, the City of Industry will meet with the City of La Puente to discuss the proposed safety measure and the need to perform work within La Puente's jurisdiction.
- 8. Prepare final plans and Bid Documents: Upon agreement between the Cities of Industry and La Puente on the conceptual layout, final plans and Bid Documents will be prepared for submission to contractors for bidding purposes.

Bidding Tasks:

9. Using plans and bid documents, obtain contractor to purchase and setup devices: The City of Industry will solicit 3 bids from contractors qualified to perform the work necessary to provide a functional RRFB system. The bids will be evaluated and a contractor will be selected to enter into contract with to setup the RRFB for the demonstration.

Temporary Installation Tasks:

- 10. Contract Administration: Once the contract has been executed between the selected contractor and the City, the City's construction manager will authorize the contractor to begin the work.
- 11.Installation: The City will provide inspection of the work as it is progressing, including documenting the progress.
- 12. Closures: The demonstration will incorporate a minimum of two street closure events that highlight the intervention and/or allow public participation and feedback. These may coincide with opening/installation and closing/removal activities, but do not need to. Full closure to cars during the events is required. There is no minimum time or programming requirement for the events.
- 13. Surveys: The demonstration will include the solicitation of feedback from the public and stakeholders using Metro's Standardized Data Collection Template. The survey may be supplemented as necessary.
- 14. Communication Materials: Public facing communications related to the demonstration will be approved ahead of time by SGVCOG and Metro staff. Materials will be sent to SGVCOG staff, who will then ensure Metro approval before dissemination.

Close Out Tasks:

15. Final Inspection: Upon completion of the installation, the City of Industry will perform a final inspection to determine the system is functioning as intended and no additional safety measures need to be implemented.

- 16. Temporary Installation Sign Off: Once the City is satisfied with the system, a Notice of Completion will be issued to the contractor.
- 17. Evaluation: The City will provide an opportunity for the surrounding community to provide feedback on the demonstration project for a period of 30 days. If the demonstration proves to be a success, the City may consider installing RRFB permanently.
- 18. Final Invoicing: After the Notice of Completion is issued, all outstanding and final invoices will be processed and payment made to the contractor.
- 19. Project Closeout: Upon final payment to the contractor and any final billings for staff and/or consultants, the City will closeout the project.
