Public Utilities Director Josh Nelson said every year we must report to the California Energy Commission (CEC), as to where our power source comes from. Dev Birla, Senior Energy Adviser at CNC Engineering, explained the Power Content Label, the dates and documentation required to the CEC in the form of a Power Source Disclosure Report for year ending December 31, 2022. He was available and happy to answer any questions. Len Viejo, Project Manager with Astrum, was online and added to the overall report.

Commissioner Ruggles asked about the power mix for 2022, in the report and Len Viejo said we buy from the system, so it is unspecified power. The percentages you see on the report are from the state. In the near term, 2023 and 2024, it's possible the IPU will be close to 100% renewable.
